# C. WCTID Program of Projects

# 1. I-71/Fields Ertel Mason-Montgomery Road Interchange Project

Mr. Corey provided a brief status report for the NB Exit – Gore Extension (ODOT PID No. 87399) and the NB Exit – Loop Ramp (ODOT PID 87401) projects, stating that these projects are moving into construction phase and ODOT will be providing the Construction Administration. The I-71 Safety Study (ODOT PID 91060) project is beginning the preliminary engineering phase.

# 2. I-71/Western Row Road Interchange Project

Mr. Corey provided a status report for the Western Row Road Interchange (ODOT PID 93964), Relocation Columbia Road (95120), and Kings Island Drive (ODOT PID 89180) projects and discussed how the three (3) projects in the I-71/Western Row Road Interchange area will be coordinated. Under new business the Board was being recommended to take action on two (2) contracts for the consultants Stantec and Rasor Marketing Communication LLC to continue advancing the project.

## 3. I-75/SR73 Interchange Project

Mr. Corey provided an overall status report for the I-75/SR 73 – Ramp C project (ODOT PID 92040) advising that the project is in the right-of-way acquisition phase.

## 4. South Lebanon – SR 48 Widening

Mr Corey stated there was not report for SR 48 Widening.

  - 5. Resolution 2013-13 Authorizing Agreement for consultant services with Rasor Marketing Communication LLC, for the I-71/Western Row Road Interchange Project. Mr. Neil Tunison made a motion and Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with each member present separately voting "Yes" thereon.
  - 6. Resolution 2013-14 Establishment of New Capital Project Fund Wilkens Boulevard Corridor Improvement Project. Mr. Bill Becker made a motion and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "Yes" thereon.
  - 7. Resolution 2013-15 Adoption and Authorization of Fund Budget for Calendar Year 2013 – Wilkens Boulevard Corridor Improvement Project. Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "Yes" thereon.

- 10. Resolution 2013-17 A Resolution to amend the General Fund 2013 budget. Mr. Bill Becker made a motion and Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with each member present separately voting "Yes" thereon.
- 11. Resolution 2013-18 Approve and authorize the execution, by the Secretary-Treasurer on behalf of the WCTID, of a purchase order with the firm, HDR Engineering for preparation of a feasibility study for the US 22/SR 3 and SR 48 Intersection Improvement project, in an amount not to exceed \$ 10,000. Ms. Christine Thompson made a motion and Mr. Bill Becker seconded the motion. Upon roll call vote, motion carried with each member present separately voting "Yes thereon.
- 12. Approve and authorize the execution, by the Secretary-Treasurer on behalf of the WCTID, of the letter of arrangement by and between the WCTID and audit firm of Auditor of State of Ohio for the provision of audit services, in the form on file with WCTID, in an amount not to exceed \$8,000. Ms. Christine Thompson made a motion and Mr. Bill Becker seconded the motion.
- Upon roll call vote, motion carried with each member present separately voting "Yes thereon.
