- D. Financial Report Neil Tunison presented the February and March 2015 Monthly Financial Report to the Board. Mr. Tunison reviewed the March 2015 Monthly Financial Report detailed both monthly and year-to-date cash activities for all funds of the TID. More specifically, the Monthly Financial Report detailed that as of March 30, 2015 the General Fund had a cash balance of \$1,062,817 and the TID as a whole had a cash balance of \$9,843,224. Further, Ms. Chris Thompson made a motion and Mr. Bill Becker seconded the motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2015-01 with CESO, Inc., dated January 30th, 2015 for the "Union/Greentree Road Intersection Improvement /WCTID No. 15-01", increasing the contract price by \$950.00, making a new not-to-exceed amount under the Agreement of \$199,741.00 with no attendant increase in contract time. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

the "Socialville-Fosters Road Widening and Bridge Replacement Project/WCTID No. 14-01", increasing the contract price by \$6,500.00, making a new not-to-exceed amount under the Agreement of \$413,700.00 with no attendant increase in contract time. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
