## A. Call to Order

A Regular Board Meeting of the Warren County Transportation Improvement District (WCTID) Board of Trustees was called to order by Dave Gully, at 9:00 a.m., on Friday, May 22<sup>nd</sup>, 2015 at the Warren County Engineers Office, 210 W. Main Street Conference Room, Lebanon, Ohio 45036.

## **B.** Approval of Minutes:

Motion made by Mr. Bill Becker seconded by Ms. Christine Thompson to approve the minutes of April 24<sup>th</sup>, 2015 Regular Meeting of the Warren County Transportation Improvement District as submitted. Upon roll call vote, all members present each separately voting "Yes" thereon.

- C. WCTID Program of Projects Mr. Corey reported to the Board that since the last meeting, no significant milestones but all projects were advancing on time and within budget. Mr. Gully recognized the construction activity that was occurring at the I-71/Fields Ertel Interchange area.
- D. Financial Report Neil Tunison presented the April 2015 Monthly Financial Report to the Board. Mr. Tunison reviewed the April 2015 Monthly Financial Report detailing both monthly and year-to-date cash activities for all funds of the TID. More specifically, the Monthly Financial Report detailed that, as of March 30, 2015, the General Fund had a cash balance of \$1,055,366 and a total cash balance of \$9,606,356. Mr. Bill Becker made a motion to accept the WCTID financial report as submitted, seconded by Mr. Neil Tunison. Upon roll call vote the motion carried with each member present separately voting "Yes" thereon

### E. New Business

- 1. Resolution 2015-10, authorizing application to ODOT for TID supplemental funding for identified projects. Ms. Christine Thompson made a motion to approve Resolution 2015-10, with modification of the header to Exhibit I, at the fifth column, to correct typographical error to read "FY 16" as opposed to "FY 15," and Mr. Bill Becker seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 2. Resolution 2015-11, A Resolution authorizing a Consultant Contract for Socialville-Fosters Road Widening Improvements with TEC Consultant, in an amount not to exceed Three Thousand One Hundred Twenty-Five Dollars (\$3,125.00). Mr. Neil Tunison made a motion and Mr. Bill Becker seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 3. Resolution 2015-12, A Resolution authorizing a Consultant Contract for Duke Boulevard Widening Improvements with Burgess & Niples, Inc., in an amount not to exceed One Hundred Fifty-Five Thousand Seven Hundred Sixty-Five Dollars (\$155,765.00). Mr. Bill Becker made a motion and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 4. Discussion City of Franklin request to adopt SR 123 Improvement Project as a WCTID project. Mr. Corey stated that because Mr. Sonny Lewis from the City of Franklin is unable to attend today's meeting, the Board may wish to table this agenda item is until the June meeting. Ms. Thompson asked for a description of the potential project. Mr. Corey explained that the project contemplates widening and improving SR 123 from within the City of Franklin limits to the intersection of SR 123 and Robinson-Vail Road. The proposed project would involve ODOT, the City of Franklin, and the County, as well as containing an economic development element. Therefore, it would be a project for further consideration by WCTID Board.
