- Consultant continues designing the project through construction document phase
- Current Construction planned for 2021

# Western Row Road Interchange Improvements - Phase 2 (PID 93964)

- NB and SB Ramps were opened!
- Construction ~ 90% complete completion date by contract June 1, 2019

## Socialville-Fosters Road (CR-32) Improvement – Phase 2

- Preliminary design options analysis completed
- Utility coordination is beginning

### Wilkens Boulevard Signals

 Construction just beginning ~ 30% complete – completion date by contract – August 1, 2019

#### SR 63 - Union Road to SR741

- BUILD Application is being prepared to be submitted by July 15th 2019
- Local Funding Plan is being discussed with stakeholders

#### Columbia Road Widening (Fitzgerald to Socialville-Fosters)

- Design work has begun
- Anticipated construction in 2019, contingent upon no utility work

#### D. Financial Report

Mr. Mark Hurst presented the February and March 2019 Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of March 30<sup>th</sup>, 2019 the General Fund had an ending fund balance of

\$794,565.97 and the WCTID as a whole had an ending fund balance of \$10,062,646.81. Mr. Neil Tunison made a motion to accept the WCTID financial report as submitted; Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

#### E. New Business

- Resolution Number 2019-08, A Resolution for Adoption and Amendment of Fund Budgets for Calendar Year 2019. Mr. Chris Pozzuto made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 2. Resolution Number 2019-09, A Resolution authorizing application to ODOT for HB62 TID supplemental project funding for Columbia Road Widening Project. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 3. Resolution Number 2019-10, A Resolution designating the Socialville-Fosters Road and Western Row Road Safety Improvement Project and approving inclusion in WCTID Transportation Program of Projects and related actions. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 4. Resolution Number 2019-11, A Resolution authorizing application to ODOT TRAC for funding transportation improvement project. Mr. Chris Pozzuto made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 5. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2019-01 with The Kleingers Group dated January 25<sup>th</sup>, 2018 for the "Columbia Road Widening Project", increasing the contract price by \$28,400.00, making the new not-to-exceed amount under the Agreement of \$100,300.00, with no attendant increase in contract time. Mr. Chris Pozzuto made the motion and Mr. Neil Tunison made the second to the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2018-10 with R L Record LLC dated December 7<sup>th</sup>, 2018 for the

"State Route 63 Corridor Improvements Project", increasing the contract price by \$26,693.61, making the new not-to-exceed amount under the Agreement of \$220,693.61, with no attendant increase in contract time. Mr. Chris Pozzuto made the motion and Mr. Neil Tunison made the second to the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
