## **SB Entrance Ramp – WAR IR 71 0.00 (PID 100198)**

- Stage 2 and Preliminary Right-of-Way Plans submitted
- Current Construction planned to start in 2021 and be completed in 2022

## Mason-Montgomery Road - Concrete Median - WAR-CR21-0.23-0.41 (PID 109613)

- Consultant continues designing the project through construction document phase
- Current Construction planned for Spring 2020

## SR 63 - Union Road to SR741

- BUILD Application was submitted on July 15th 2019
- At TRAC Committee's Work Session held on September 25<sup>th</sup>, SR 63 was discussed and considered to be awarded \$5M for ROW. The DRAFT Work Session will be held on October 9<sup>th</sup>, and the FINAL Work Session will be held on November 6<sup>th</sup>.
- Local Funding Plan is being discussed with local stakeholders

# Columbia Road Widening (Fitzgerald to Socialville-Fosters)

- Bids were received on September 24<sup>th</sup> and part of New Business
- Anticipated construction in 2019 and being completed in 2020

## D. Financial Report

Mr. Mark Hurst presented the August 2019 Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of August 31<sup>st</sup>, 2019 the General Fund had an ending fund balance of \$918,344.22 and the WCTID as a whole had an ending fund balance of \$10,682,583.06.
