C. Approval of Minutes:

Motion made by Ms. Tiffany Zindel and seconded by Mr. Eric Reiners to approve the minutes of the December 7th, 2019 Regular Board Meeting of the Warren County Transportation Improvement District as submitted. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- Anticipate award of construction contract at February 28, 2020 Board meeting

SR 63 – Union Road to SR741

- Coordinating with Duke Energy regarding relocation of pole lines
- Duke Energy to submit a preliminary alignment for a utility corridor located on the State's prison property

Columbia Road Widening (Socialville-Fosters to Fitzgerald)

- Construction Phase ongoing
- Completion date based on construction contract is May 31, 2020

Contract Time Extension(s):

Change Order 02 for Contract No. 2016-04 with Rasor Marketing Communications, LLC will be issued increasing the contract from December 31, 2019 to December 31, 2021, with no increase to the contract price.

D. Financial Report

Mr. Mark Hurst presented the December 2019 Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of December 31st, 2019 the General Fund had an ending fund balance of \$1,096,695.57 and the WCTID as a whole had an ending fund balance of \$9,529,573.40. Mr. Neil Tunison made a motion to accept the WCTID financial report as submitted; Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

E. New Business

- Resolution Number 2020-01, a Resolution for Adoption and Amendment of Fund Budgets for Calendar Year 2020. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- Resolution Number 2020-02 A Resolution approving and authorizing closeout work for the Greentree/Union Road Intersection Improvement Project. Mr. Eric Reiners made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- Resolution 2020-03, A Resolution approving and authorizing close-out work for the Wilkens Boulevard Traffic Signals Project. Mr. Neil Tunison made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 4. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2019-03 with WSP USA, Inc. dated February 22nd, 2019 for the "Wilkens Boulevard Corridor Improvements", increasing the contract price by \$298,161, making the new not-to-exceed amount under the Agreement of \$427,439.96, with an attendant increase in contract time through July 31st, 2021. Mr. Eric Reiners made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 5. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 and Change Order 2 to Contract No. 2018-04 with Elex, Inc. dated October 26th, 2018 for the "Wilkens Boulevard Corridor Improvements", increasing the contract price by

\$6,602.14 and \$2,347.42 respectfully, making the new not-to-exceed amount under the Agreement of \$571,254.21, with an attendant increase in contract time through February 29th, 2020. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
