- Stage 3 Plans and have been submitted
- R/W Acquisition will be cleared in February
- Duke Energy relocation to begin in February
- Estimated Begin of Construction is March 2024 with completion November 2025
- Wilkens/Bardes Roundabout Part 2 of PID 114606
  - Stage 3 Plans and R/W plans has been submitted
  - R/W anticipated to be cleared by the end of 2023

# Irwin-Simpson Multiuse Path Improvements (PID 114603)

- Stage 2 Plans completed on 1/9/22
- R/W Acquisition Complete 7/7/23
- Estimated Begin of Construction is April 2024 with completion November 2025

# I-71 & SR 48 Interchange Phase 1 - WAR-48-9.94 (PID 116865) Phase 2

- Feasibility Study completed
- Transportation Systems Maintenance & Operations (TSMO) application was successful by receiving \$1.5M toward the interchange project, completing Phase 1
- ODOT/WCTID reviewing Scope/Fee from B&N and existing contract will be modified
- ODOT D-8 has agreed to consider submitting for Safety Funds or TSMO for Phase 2 Construction

# SR 48 - Ridgeview/Saddle Creek to Mason-Morrow-Millgrove Road including LMR bridge

Michael Baker was selected as the consultant. On January 20,
 WCEO/ODOT and Michael Baker are meeting to discuss the scope. After this meeting the fee will begin to be prepared.

# <u>US 22/SR 3 Corridor - Old 3C/Creekwood roundabout and Hoptown Planning Study</u>

Mead Hunt is beginning survey work. A meeting was held on January 12 with Mead Hunt and ODOT to discuss the approach to the traffic analysis.

### King Avenue at King Court Intersection Improvements

Construction has begun with completion anticipated in December 2023

### SR 741/Greentree Road Intersection Improvements

- Stage 1 Plans have been completed
- Preliminary R/W Plans have been submitted
- Environmental Clearance work continues

### Columbia Road and Davis Road Intersection Improvement

- Alternatives Study has been completed and a Preferred Alternative has been chosen
- Design is being advance with the anticipation of hiring a Right-of-Way Acquisition Services

### Columbia Road and Mason-Morrow-Millgrove Road Roundabout

Design and R/W Plans have been submitted and are under review

### Wm Good Boulevard Extension/Scholl Road Improvements

- WCTID will be a funding partner to Franklin
- Franklin has bid the project and issuing the contract

### E. Financial Report

Mr. Mark Hurst presented the November and December Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of December 31<sup>st</sup>, 2022 the General Fund had an ending fund balance of \$ 385,069.03 and the WCTID as a

whole had an ending fund balance of \$ 17,290,099.35. Mr. Eric Hansen made a motion to accept the WCTID financial report as submitted; Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 3. Resolution 2023-03, a Resolution Authorizing and Approving Consultant Agreement for Right-of-Way Acquisition Services with Briggs Creative Services, LLC for WAR-TR55-2.11 PID 114603 RW. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Eric Hansen seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 4. Resolution 2023-04, a Resolution approving and authorizing utility construction services for the SR 63 Widening Project (aka WAR-SR63-0.83 PID 112121) with INTERN. Mr. Eric Hansen made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 5. Resolution 2023-05, a Resolution Authorizing and Approving Consultant Agreement for Right-of-Way Acquisition Services with Martin+Wood Appraisal Group, Ltd. for King Mill Rd (CR31) / Kings Island Drive (CR 110) Improvement 2023. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Eric Hansen seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 6. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and submit a Right-of-Entry application to Genesee & Wyoming Railroad Services, Inc. for the SR 63 Widening Project (aka WAR-SR63-0.83 PID 112121) and to pay the application fee of \$3,500.00. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Eric Hansen seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 7. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 03 to Consultant Agreement 2020-02 with Woolpert dated April 3, 2020 for the "SR 48 and US22/SR3 Intersection

Improvement Project", increasing the contract price by \$50,397 making the new not-to-exceed amount under the Agreement of \$1,400,397 with no change in the contract time of June 1, 2023. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Eric Hansen seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

8. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2021-03 with Jacobs Engineering Group Inc. dated March 26th, 2021 for the "SR 63 Reconstruction, WAR-63-0.83 (PID 112121)", increasing the contract price by \$123,500 making the new not-to-exceed amount under the Agreement of \$1,442,984 with no change in the contract time of December 30th, 2023. Mr. Neil Tunison made a motion to approve the Resolution and Mr. Eric Hansen seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
