# I-71 & SR 48 Interchange Phase 1 - WAR-48-9.94 (PID 116865) Phase 2

- Feasibility Study completed
- Transportation Systems Maintenance & Operations (TSMO) application was successful by receiving \$1.5M toward the interchange project, completing Phase 1
- ODOT/WCTID reviewing Scope/Fee from B&N and existing contract will be modified
- ODOT D-8 has agreed to consider submitting for Safety Funds or TSMO for Phase 2 Construction

# SR 48 - Ridgeview/Saddle Creek to Mason-Morrow-Millgrove Road including LMR bridge

Michael Baker was selected as the consultant. On January 20,
 WCTID/ODOT and Michael Baker are meeting to discuss the scope.
 Michael Baker developed scope and submitted to WCTID/ODOT.
 Comments were provided to Michael Baker on 2/17/23. Fee is anticipated to be completed and agreed to for the 3/24/23 Board Meeting.

# <u>US 22/SR 3 Corridor - Old 3C/Creekwood roundabout and Hoptown Planning Study</u>

 Mead Hunt is beginning survey work. A meeting was held on January 12 with Mead Hunt and ODOT to discuss the approach to the traffic analysis.

### King Avenue at King Court Intersection Improvements

• Construction has begun with completion anticipated in December 2023

### SR 741/Greentree Road Intersection Improvements

- Stage 1 Plans have been completed
- Preliminary R/W Plans have been submitted
- Environmental Clearance work continues

### Columbia Road and Davis Road Intersection Improvement

- Alternatives Study has been completed and a Preferred Alternative has been chosen
- Design is being advance with the anticipation of hiring a Right-of-Way Acquisition Services

### Columbia Road and Mason-Morrow-Millgrove Road Roundabout

• Design and R/W Plans have been submitted and are under review

### Wm Good Boulevard Extension/Scholl Road Improvements

- WCTID will be a funding partner to Franklin
- Franklin has bid the project and issuing the contract

### E. Financial Report

Mr. Dan Corey presented the January Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of January 31<sup>st</sup>, 2023 the General Fund had an ending fund balance of \$ \$371,117.24 and the WCTID as a whole had an ending fund balance of \$ 22,584,750.86. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Construction Contract 2022-01 in relation to the King Avenue at King Court Intersection Improvements; Part 1 King Avenue Turn Lane Improvements; Part 2 King Ave. (CR 282)/Kings Ct. Intersection Improvements; Part 3 Waterline Improvements King Avenue Miami St. increasing the contract price by \$829,948.00 making the new contract amount equal to \$3,593,211.35. Mr. Eric Reiners made a motion to approve the Resolution and Mr. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
