<u>I-75 & SR 73 Interchange Improvements – WAR SR 73 3.66 (PID 113717)</u>

- Open Bid on 3/14. The Apparent Low Bidder was Sunesis Construction Company
- WCTID is waiting on ODOT approval to award the project
- Estimated Begin of Construction is May 2023 with completion November 2024

Fields-Ertel Road Widening – Snider to Wilkens Boulevard (PID 114606)

- R/W Acquisition has been cleared
- Duke Energy has mobilized onsite and began to remove trees
- Utility work should start in April and be completed in 2023
- Estimated Begin of Construction is March 2024 with completion November 2025

• Wilkens/Bardes Roundabout - Part 2 of PID 114606

- Stage 3 Plans and R/W plans has been submitted
- R/W anticipated to be cleared by the end of 2023

<u>Irwin-Simpson Multiuse Path Improvements (PID 114603)</u>

- Stage 2 Plans completed on 1/9/22
- R/W Acquisition Complete 7/7/23
- Estimated Begin of Construction is April 2024 with completion November 2025

<u>I-71 & SR 48 Interchange Phase 1 - WAR-48-9.94 (PID 116865) Phase 2</u>

- Feasibility Study completed
- Transportation Systems Maintenance & Operations (TSMO) application was successful by receiving \$1.5M toward the interchange project, completing Phase 1

- ODOT/WCTID reviewing Scope/Fee from B&N and existing contract will be modified
- ODOT D-8 has agreed to consider submitting for Safety Funds or TSMO for Phase 2 Construction

SR 48 - Ridgeview/Saddle Creek to Mason-Morrow-Millgrove Road including LMR bridge

• Board is being asked to place Michael Baker International under contract as part of 3/30/23 New Business.

<u>US 22/SR 3 Corridor - Old 3C/Creekwood roundabout and Hoptown Planning Study</u>

 Mead Hunt is beginning survey work. A meeting was held on January 12 with Mead Hunt and ODOT to discuss the approach to the traffic analysis.

King Avenue at King Court Intersection Improvements

Construction has begun with completion anticipated in December 2023

SR 741/Greentree Road Intersection Improvements

- Stage 1 Plans have been completed
- Preliminary R/W Plans have been submitted
- Environmental Clearance work continues

Columbia Road and Davis Road Intersection Improvement

- Alternatives Study has been completed and a Preferred Alternative has been chosen
- Design is being advance with the anticipation of hiring a Right-of-Way Acquisition Services

Columbia Road and Mason-Morrow-Millgrove Road Roundabout

• Design and R/W Plans have been submitted and are under review

Wm Good Boulevard Extension/Scholl Road Improvements

- WCTID will be a funding partner to Franklin
- Franklin has bid the project and issuing the contract

E. Financial Report

Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute a Modification to Contract 2023-04, related to SR 63 Widening Improvement Project (PID 112121), with INTREN to increase the contract amount by \$44,768.02 making the new contract amount equal to \$273,855.02 as a result of additional related work under the contract requested by ODOT and related cost. Mr. Eric Reiners made a motion to approve the Resolution and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

Mr. Tom Gottlieb asked if New Business Item 4 would impact the Hunters Ridge Property. It was expressed by Mr. Dan Corey, Mr. Steve Mary, and Mr. Duane Phelps, who are Fields-Ertel Project Team members who were in attendance, that the work associated with Item 4 would not impact Hunters Ridge. Mr. Tom Gottlieb further stated that at the October 28, 2022 he made public comments that were not reflected in the Board's minutes. Ms. Tiffany Zindell expressed that his comment is noted, and the October 28, 2022 minutes would be changed to reflect that he made comments.
