Kings Mill Road (CR31)/Kings Island Drive (CR110) Improvements 2023

E. Financial Report

Mr. Dan Corey presented the May Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of May 31st, 2023 the General Fund had an ending fund balance of \$399,089.37 and the WCTID as a whole had an ending fund balance of \$27,582,754.33. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 04 to Consultant Agreement 2020-02 with Woolpert dated April 3, 2020 for the "SR 48 and US22/SR3 Intersection Improvement Project", increasing the contract price by \$90,842.00 making the new not-to-exceed amount under the Agreement of \$1,491,239.00 and increasing the contract time from December 1, 2023 to December 1, 2024. Mr. Eric Reiners made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 04 to Consultant Agreement 2021-01 with MAKSolve Inc. dated May 1, 2021 for the "BP Gas Station 9855 Mason-Montgomery Road", increasing the contract price by \$16,710.00, making the new not-to-exceed amount under the Agreement of \$286,520.00 with no increase in contract time. Mr. Chris Pozzuto made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2021-03 with Jacobs Engineering Group Inc. dated March 26th, 2021 for the "SR 63 Reconstruction, WAR-63-0.83 (PID 112121)", increasing the contract price by \$63,860.00 making the new not-to-exceed amount under the Agreement of \$1,506,844.00 with no change in the contract time. Mr. Eric Reiners made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 9. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 03 to Consultant Agreement 2021-05 with Jacobs Engineering Group Inc. dated March 12th, 2021 for the "SR 741 and Greentree Road Intersection Improvements", increasing the contract price by \$54,314.00, making the new not-to-exceed amount under the Agreement of \$716,958.00 with no increase in contract time. Mr. Chris Pozzuto made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll

call vote, motion carried with each member present separately voting "yes" thereon.
