### SR 48 and US22/SR3 Intersection Improvements – WAR SR 48 7.01 (PID 112909)

- Sunesis Construction Company preparing to mobilize
- Estimated Construction completion is November 2024

### SR 63 – Union Road to SR741 – WAR SR 63 0.83 (PID 112121)

- Continue working on moving utilities prior to construction
- R/W Acquisition complete 7/21/23
- Sale of construction project is schedule to be October 27<sup>th</sup>, 2023 Board Meeting
- Estimated Begin of Construction is December 2023 with completion October 2025

### Mason-Morrow-Millgrove Road Realignment - WAR CR38 (PID 113722)

- Sale of construction project is to be determined due to multiple projects which have conflicts with their maintenance of traffic closures
- Estimated Begin of Construction is to be determined

### SR 741 and Remick Boulevard Intersection – WAR SR741 17.21 (PID 113721)

- Estimated Construction completion is November 2023

### I-75 & SR 73 Interchange Improvements – WAR SR 73 3.66 (PID 113717)

## US 22/SR 3 Corridor - Old 3C/Creekwood roundabout and Hoptown Planning Study

 Mead Hunt, WCTID, and ODOT held a preliminary geometric roundabout meeting on May 10<sup>th</sup>

### King Avenue at King Court Intersection Improvements

• Estimated Construction completion is December 2023

### SR 741/Greentree Road Intersection Improvements

- Stage 3 and Final R/W Plans have been submitted for review
- Environmental Clearance work continues

### Columbia Road and Davis Road Intersection Improvement

- Stage 2/3 has been submitted for review
- Right-of-Way Acquisition Services consultant is part of New Business

### Columbia Road and Mason-Morrow-Millgrove Road Roundabout

- Final design and R/W Plans have been submitted and are under review
- R/W acquisition team is under contract

### Wm Good Boulevard Extension/Scholl Road Improvements

- WCTID is a funding partner to Franklin
- Franklin has opened the road to traffic

### Kings Mill Road (CR31)/Kings Island Drive (CR110) Improvements 2023

- John R. Jurgensen is under contract and will commence construction once utilities and right-of-way is cleared in a portion of the project area
- Estimated Construction completion is 2024

### D. Financial Report

Mr. Neil Tunison presented the June and July Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of July 31<sup>st</sup>, 2023 the General Fund had an ending fund balance of \$448,407.74 and the WCTID as a whole had an ending fund balance of \$30,249,973.92. Mr. Eric Reiners made a motion to accept the WCTID financial report as submitted; Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 3. Resolution 2023-35, a Resolution Approving and Authorizing Notice to Contractors and Acceptance of Bids for Constructions Services for the SR 63 Widening Project. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 4. Resolution 2023-36, a Resolution Approving and Authorizing Notice to Contractors and Acceptance of Bids for Constructions Services for Irwin-Simpson Multiuse Path Project. Mr. Eric Reiners made a motion to approve the Resolution and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 5. Resolution 2023-37, a Resolution Authorizing and Approving Notice to Contractors and Acceptance of Proposals for Demolition Services for Columbia Road/Davis Road/Myrtle Drive Roundabout Project. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

Motion by Ms. Tiffany Zindel to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 04 to Consultant Agreement 2019-03 with WSP dated February 22, 2019 for the "Wilkens Blvd Corridor Improvements", increasing the contract price by \$60,704.00 making the new not-to-exceed amount under the Agreement of \$723,632.96 with no increase in time. Mr. Eric Reiners seconded the Motion and upon roll call vote, said Motion passed with each member present voting "yes" thereon.
